

## Nexus Airlines "2 for 1" Offer

### Terms and Conditions

**The Offer:** Book 2 for 1 return flights from Geraldton, Karratha or Port Hedland to Broome. **Promo code:** BROOMETIME **Offer period:** As published on the Nexus Airlines website at <https://nexusairlines.com.au/2-for-1-flights-to-broome/> unless extended by Nexus Airlines.

By entering the Promo Code when booking on the Nexus Airlines website, you agree to these Terms and Conditions. These Terms and Conditions apply together with the Nexus Airlines [Conditions of Carriage](#) and the fare rules of the fare type you book.

### The Offer

1. When you make a booking using the Promo Code, you and each other passenger in your booking receive 50% off the total fare, including applicable taxes, fees, charges and GST(**Offer**).
2. Any payment surcharge shown at checkout is not discounted and remain payable in full.

### To use the Promo Code, all four eligibility criteria must apply

3. The Offer is only available where **all four** of the following criteria are satisfied at the time you book and at all times up to travel:
  - a. Everyone in your booking is flying with Nexus Airlines to Broome from Geraldton, Karratha or Port Hedland on a return itinerary, with both flights booked on the same itinerary.
  - b. Your booking is for at least 2 passengers, booked under the same booking reference, travelling together on the same outbound and return flights. Bookings are capped at 9 passengers.
  - c. Your booking is made at least 30 days before the scheduled departure date of your outbound flight.

Together, these are the **Promo Code Eligibility Criteria**.

### Please read these clauses carefully.

4. **It is your responsibility to ensure your booking meets the Promo Code Eligibility Criteria before completing payment.**
5. The Promo Code may work even if your booking doesn't meet the Promo Code Eligibility Criteria. For example, the system may allow the Promo Code to be applied to a single-passenger booking or multi-passenger bookings where passengers are travelling on different routes. Just because the Promo Code goes through, it doesn't mean your booking is eligible for the Offer - please double-check before you pay.
6. Nexus Airlines will use reasonable endeavours to identify any booking that does not meet the Promo Code Eligibility Criteria as soon as practicable after booking and we will notify you as soon as we reasonably can.
7. If, at any time before the scheduled departure of the outbound flight, Nexus Airlines reasonably determines that a booking made using the Promo Code does not meet the Promo Code Eligibility Criteria, Nexus Airlines will notify you and give you a reasonable opportunity (taking into account the time remaining before departure) to either:
  - a. amend the booking so that it meets the Promo Code Eligibility Criteria, subject to availability and payment of any fare difference; or
  - b. pay the fare difference to re-price the booking to the applicable published fare without the Offer discount.

8. If you do not amend the booking or pay the fare difference within the time reasonably specified by Nexus Airlines, Nexus Airlines may cancel your booking (and any associated return sector) and will refund in full the amounts you paid for the cancelled sector(s), except where Nexus Airlines reasonably suspects the booking was made fraudulently or dishonestly.
9. Nexus Airlines may exercise its rights under this clause even if the booking has been confirmed, a ticket has been issued, or the Promo Code was accepted by the booking system.
10. Travel (both outbound and return sectors) must be commenced and completed by 31 March 2027.
11. Bookings under the Offer are subject to availability.
12. The Promo Code provides a discount off an existing published fare type. All fare rules of the fare type booked continue to apply.
13. If you change or cancel any part of your booking, the change/cancellation fees of the underlying fare type apply.
14. All travel is subject to the Nexus Airlines [Conditions of Carriage](#), which form part of these terms. If there is any inconsistency between these terms and the Conditions of Carriage, these terms prevail to the extent of the inconsistency, in relation to the Offer only.
15. The Promo Code is non-transferable and has no cash or credit value.
16. Nothing in these terms excludes, restricts or modifies any rights or remedies you may have under the Australian Consumer Law (Schedule 2 to the Competition and Consumer Act 2010 (Cth)) or other applicable consumer protection laws that cannot be lawfully excluded.
17. The Offer is available during the Offer period published on the Nexus Airlines website at <https://nexusairlines.com.au/2-for-1-flights-to-broome/>. Nexus Airlines may extend the Offer period (including more than once) by updating the published end date. Nexus Airlines will not shorten the Offer period or withdraw the Offer before the then-current published end date, except where required by law or for reasons outside its reasonable control. Any withdrawal will not affect bookings already confirmed under the Promo Code.
18. Nexus Airlines may amend these terms where reasonably necessary (for example, to correct an error or comply with law or regulator guidance). Any amendment will not adversely affect bookings already confirmed under the Promo Code before the date of the amendment.
